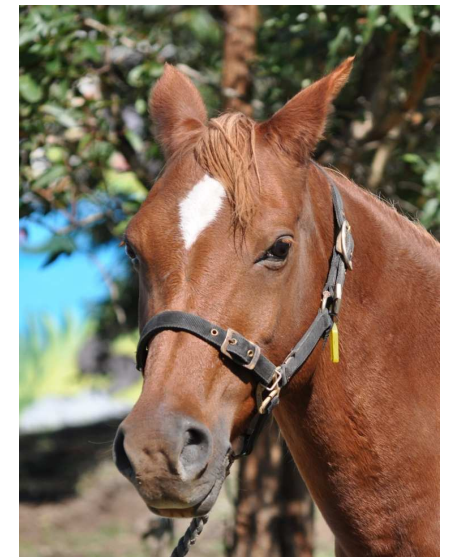

About RDA

The Riding for the Disabled (RDA) Raymond Terrace & Lower Hunter Centre aims to improve the quality of life of people with a disability.

Our Riding, Carriage Driving and Dressage programs create opportunities for people with a disability across the Hunter Region to participate in recreational activities in a fun, safe and supportive environment.

How the Centre is Funded

We receive no Federal or State funding to operate our therapeutic and educational programs.

Riders and drivers are charged fees that reflect their financial circumstances. This is combined with annual fundraising activities and community donations to meet the annual operating costs of the Centre

Our Horses

RDA has 16 horses involved in our programs every year. We have two carriage driving horses, specialist dressage horses, two driving ponies and general riding horses to meet our riders' needs.

On average, it costs \$1,500 to keep one horse

for a year. This includes feed, veterinary care, dental, worming, vaccinations and hoof care.

What is Share-A-Horse?

Share-A-Horse is a unique fundraising project that encourages members of the community to become directly involved in supporting people with a disability and Riding for the Disabled by sponsoring our horses.

Sponsors are able to purchase one share in one of our horses for \$30. You can buy as many shares as you like and you can sponsor a number of horses at the same time.

Full sponsorship is \$1,500.

All Donations are Tax Deductible

All donations made to our Share-A-Horse Project over \$2 are fully tax deductible.

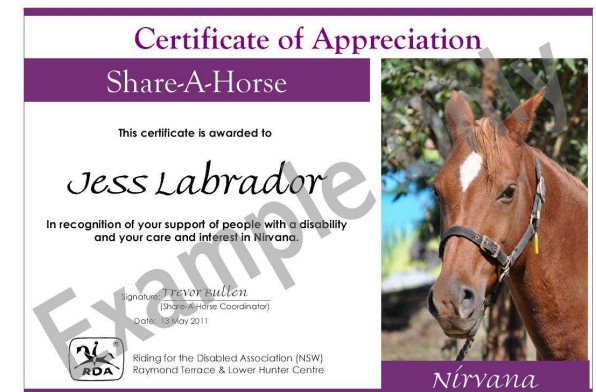
